## Reports and Discussion

Mr. Simmons, Elementary Principal, reported on the Missoula Children's Theatre. 62 students K-8 participated. The performance was well attended, and they have been booked to return for the Spring of 2025. He also reported on the NSCAS testing due to
begin on April 10. There will be a Pep Rally for the students on April 16 to encourage them to do their best on this testing. Field trips are beginning with the goal of combining fun and education. Mother's Day pots have been ordered for the Greenhouse. Reassignment of teachers is as follows: Mrs. Rodak will be moving to Jr High English, Mr. Jase Dean will be moving to High School Math and Science, Ms. Soto will be moving to Sixth Grade, and Ms. Vasquez will be moving to Third Grade. Lauren Gasseling has been hired for Fifth Grade, Derrick Wells has been hired to teach Elementary PE, and Lindsey Ellis has been hired to teach First Grade. Summer school is scheduled for 10 half days this summer, and Kinder Camp has also been scheduled for the incoming Kindergarteners, for the weeks of June 3 and June 10.

Mrs. Reynolds, Principal of Instruction, reported on NSCAS testing and School Improvement. She also discussed some of the things the Special Education department has been working on, including working with local businesses to teach life skills to the students, Target Improvement Plan that has been submitted for $24-25$ with the focus being on K-3 Reading, Part C students and how they are referred, Part B students and work that is being done to help with transition. Transition is the focus of Indicator 13 this year.

Mr. Blanco, High School Principal, reported on spring activities and some of the upcoming track meets and golf meets. District Music is being held at WNCC on April 18. Marie Brown and Marlana Soto will be the new cheer sponsors, the West Nebraska Arts Center Visionaries awarded Kaylee Barnett Best of Show, Janet Sosa Barron Best in Division 1; the Audrey Towater Awards for Outstanding Artwork was awarded to Nicole Stuckey, Hanna Berrry, Alaina Jeffords, and Katherine Eckhardt; Outstanding Artwork Awards were awarded to Gaycyn Abbot, Dixon Leisy, and Katherine Eckhardt. ACT testing went well, Pre-ACT prep for Sophomores and Juniors is ongoing, and Jr High NSCAS testing begins this week. Radios are scheduled to arrive in May or June to assist Administration with coordinating fire drills and busses, and fobs are being replaced.

Mr. Schlothauer, Superintendent, reported that 20 students have been enrolled in Pre-School with three on a waiting list. Over $\$ 42,000$ has been raised for the Pre-School Playground. Staff Appreciation dinner is scheduled for May 15 at 6:00 PM. A correction on the glossy calendar is being made that the last day of school is May 15 rather than May 16. WNCC is interested in purchasing Bus \#10, Kraupie's will be placing some of the buses and unused vehicles online for sale, and quotes are being submitted to replace a route bus. He also discussed upcoming events: April 12-Awards Day, April 25-FFA Banquet, April 30-K-6 Spring Concert, May 6-Academic Banquet, May 7-Fine Arts Night and 7-12 Spring Concert, and graduation on May 11. There were some roof leaks the weekend of April 6-7, and roofers will be doing the repairs. 600 pairs of Eclipse glasses were picked up by students and community members.
